Get to know STEQEYMA, an FDA-approved biosimilar to Stelara® (ustekinumab)

STEQEYMA is a prescription medicine used to treat:

- Moderate to severe plaque psoriasis in adults and children 6 years and older who may benefit from taking injections or pills (systemic therapy) or phototherapy (treatment using ultraviolet light alone or with pills)
- Active psoriatic arthritis in adults and children 6 years and older
- Moderately to severely active Crohn's disease in adults
- Moderately to severely active ulcerative colitis in adults

It is not known if STEQEYMA is safe and effective in children less than 6 years of age.

Do not take STEQEYMA if you are allergic to ustekinumab products or any of the ingredients in STEQEYMA.

What is STEQEYMA?

STEQEYMA is a prescription biosimilar

STEOEYMA is a biosimilar of Stelara®. Biosimilar means that:

- The biological product is approved based on data demonstrating that it is highly similar to an FDA-approved biological product, known as a reference product
- There are no clinically meaningful differences in how it works or in how safe it is compared to the reference product

A biosimilar is typically more affordable than the reference product.

Since STEQEYMA is a biosimilar of Stelara, it can be used instead of Stelara.

Similar to Stelara, STEQEYMA works on the immune system to protect your body from inflammation

STEQEYMA shuts down signals in your immune system, preventing them from activating certain inflammatory immune cells. By doing so, STEQEYMA can reduce inflammation.

Why did my doctor prescribe STEQEYMA?

Your doctor prescribed STEQEYMA to treat your immune-related condition. STEQEYMA has been shown to help:



Moderate to severe plaque psoriasis in adults and children 6 years and older who may benefit from taking injections or pills (systemic therapy) or phototherapy (treatment using ultraviolet light alone or with pills)

Plaque psoriasis is a chronic autoimmune skin condition characterized by the formation of raised red and scaly patches on the skin. These patches, or plaques, often have a silvery-white appearance, can be itchy and painful, and can sometimes bleed.



Active psoriatic arthritis in adults and children 6 years and older

Psoriatic arthritis is a type of inflammatory arthritis affecting some people with plaque psoriasis. It can affect joints on one or both sides of the body, causing pain, swelling, and stiffness. The joints most commonly affected are the fingers and toes, but it can also affect other joints such as the knees, hips, and spine.



Moderately to severely active Crohn's disease in adults

Crohn's disease is a type of inflammatory bowel disease that causes chronic inflammation in the digestive tract. It can affect any part of the digestive tract, from the mouth to the anus.



Moderately to severely active ulcerative colitis in adults

Ulcerative colitis is a chronic inflammatory bowel disease that affects the colon and rectum. It is characterized by inflammation and ulcers (sores) in the lining of the colon and rectum, which can lead to symptoms such as abdominal pain, diarrhea, and rectal bleeding.



How STEQEYMA can help

STEQEYMA was shown to be as effective and safe as Stelara®

In a clinical study of 509 patients with moderate to severe plaque psoriasis, STEQEYMA was shown to be as effective as Stelara in reducing the severity of symptoms and decreasing the area affected.



STEQEYMA and Stelara delivered similar results—67% of STEQEYMA patients and 61% of Stelara patients achieved 90% improvement in plaque psoriasis symptoms.

STEQEYMA is approved to treat other diseases it has not been directly tested on in studies. The FDA looks at a wide variety of tests and data to determine that a drug is biosimilar to a reference product, including clinical trials, blood and immune-system evaluations, and chemical analyses. STEQEYMA has been approved by FDA as a biosimilar to Stelara.

Side effects for STEQEYMA

Common side effects of STEQEYMA include:

- nasal congestion, sore throat, and runny nose
- upper respiratory infections
- fever
- headache
- tiredness
- itching
- · nausea and vomiting

- · redness at the injection site
- · vaginal yeast infections
- · urinary tract infections
- sinus infection
- bronchitis
- diarrhea
- stomach pain

These are not all of the possible side effects of STEQEYMA.



Designed for safe and efficient administration

STEQEYMA is available in single-dose, prefilled syringe injections that offer you the flexibility and control of self-administration

You'll be shown how to use the injection by your doctor or a specialized nurse so you can give yourself the injection at home.



Do not try to inject STEQEYMA yourself until you or your caregiver have been shown how to inject STEQEYMA by your doctor or nurse.


PFS, prefilled syringe.

The STEQEYMA passive needle guard prevents needle-stick injuries, for added safety during administration. Plus, its ergonomic design allows easy, one-handed injection activation, for comfort and convenience during use.

Convenient administration



Finger flange to improve grip comfort

The inclusion of a finger flange in the injection design aims to enhance grip comfort by providing an ergonomic extension for the fingers, allowing for a more secure and comfortable grip on the device.



Storage for up to 15 days at room temperature (up to 86°F)

STEQEYMA demonstrates stability for a duration of up to 15 days when stored at room temperature, specifically at a maximum of 86°F.

At room temperature, the syringe must be kept in the original carton to protect it from light and discarded if not used within the 15-day period.

STEQEYMA prefilled syringes can be stored up to 3 years in a refrigerator (36° to 46°F).

Less injection-related pain, allergy, and injury



A 27-gauge special thin wall (STW) needle

A 27-gauge STW needle is employed in the STEQEYMA device to alleviate needle-related anxiety and pain perception.





Removal of citrate buffers

By being citrate free, the injection is designed to reduce discomfort associated with self-injections, as citrate buffers are known to cause pain.



Does not contain natural rubber latex

The STEQEYMA device is designed to be latex free, ensuring that patients with latex allergies can safely utilize it without any risk of adverse reactions.



Passive needle guard

By incorporating a passive needle guard, the STEQEYMA device provides a protective measure to prevent any accidental needle stick injuries during use.

What should I know before self-injecting?

Make sure you speak with your doctor

You should consult with your doctor before you start your STEQEYMA injections. Use STEQEYMA exactly as your doctor tells you to.

It is also important that you know the do's and don'ts of handling the device.

DO	DON'T
Leave syringe outside of the carton for 30 minutes to allow it to reach room temperature.	Do not warm the prefilled syringe using heat sources such as hot water or a microwave.
Check the expiration date on the carton and the label of the prefilled syringe.	Do not use the injection if the expiration date has passed.
Make sure you have the correct medicine and dosage.	Do not use the injection if you are allergic to ustekinumab or any of the other ingredients of STEQEYMA.
Check the prefilled syringe to make sure it is not cracked or damaged.	Do not use the injection if you have an active infection which your doctor thinks is important.
Look at the medicine and confirm that the liquid is clear to slightly opalescent and colorless to pale yellow.	Do not shake the prefilled syringes or use the injection if the medicine has been shaken strongly.
